3. Proceedings adjourned for Presentations:

Vivienne Scott moved Standing Orders be suspended for the presentation by the guest speakers:

The Wyong Shire Councils' Director of Infrastructure Management, **Greg McDonald** presented on "**Responsibilities of WSC's Infrastructure Management Section**" Greg gave a detailed description of the large role his directorate plays in the work Council does with over half of Council's annual budget being expended by his Directorate alone. Hervé Nayna thanked Greg on behalf of TEPCP saying that Greg's presentation was only useful but informative. At 8:05 after the presentation a short break was taken and the Meeting continues at 8:15.

- 4. Matters Arising: The Secretary advised that the matters were covered in the Correspondence report..
- 5. **Correspondence:** Copies of the Correspondence Report provide to the meeting, copy attached. **Business Arising:**
 - 5.1 WSC advised better regulations were being put in place to stop illegal camping on Karangi Reserve
 - 5.2 TEPCP advised Council it still wished to receive hard copy of Council's Business Paper.
 - 5.3 TEPCP Executive Members; the Chair, Vice Chair and Secretary will be part of the twenty strong team known as The Entrance Town Centre Masterplan Project Stakeholder Liaison Team.
 - 5.4 TEPCP has written to Council requesting improved exhibition of Papers on Public Exhibition; litter management on the shared path and the sea grass wrack at Saltwater Creek.
 - 5.5 The Secretary advised we had written two letters to WSC requesting a Service Requests for the rapid removal of tagging on Council assets. The Secretary took the opportunity to display the So-Safe Graffiti Removal Bucket. It contains Instructions, spray bottle of graffiti remover, gloves, goggles and a cloth to wipe off the graffiti. They cost about \$40.00 but WSC residents who are attacked by graffiti can get the kit from Council for free.
 - 5.6 TEPCP is campaigning against against the granting of a new Liquor Licence in Long Jetty because of the proven link between an increase in the number of Liquor outlets and an increase in domestic violence in the community. To this end TEPCP has written to the applicant, Wyong Shire Council, The Member for The Entrance, Chris Spence; The Minister for the Central Coast, Chris Hartcher and the Minister responsible for granting Liquor Licences, George Souris. The Chair acknowledged and thanked Doug and Anne Rowland for their input into this submission.
 - 5.7 TEPCP has put in a submission on the Tuggerah Lakes Flooding Risk Management Plan. The Chair thank Douig for his initiative in drafting the submission TEPCP stressed the need to integrate TLFRMP Plan with the Coastal Management Plan. Also we recommended that WSC progressively measure the levels of the lake and implement action as required rather than in gearing everything to predicted but not conclusive 2030 water level rises.
 - 5.8 TEPCP has invited Councilors to attend a workshop to be held here on Saturday 23rd July at 10.00am
 - 5.9 The Mayor, Doug Eaton has requested and been accepted to address our next meeting on the amalgamation of Gosford and Wyong Councils.
 - 5.10 The Secretary reported that he was unable to confirm with David Ryan whether or nor DECCW could present to our June 21, 2011 meeting.

- 5.11 The Chair reported that she had written to Chris Spence and Chris Hartcher on behalf of TEPCP congratulating them on their recent success in the recent State Government elections.
- 6. Treasurer's Report: Charles Harvey moved his report, Seconded V McKendrick of a Credit Balance of \$244.22. Charles advised that he had made a formal request for funds to cover our Workshop/BBQ on 23rd July, 2011. TEPCP has not received confirmation of the waiving of Executive Meeting room rental but Charles advised we were not being invoiced. for these meetings.

7. General Business:


